Essential Functions

- 1. Plans, designs, develops, executes, and/or manages strategies and programs for academic related programs/groups/services (may assists in tois function rather than be solely responsible in the lower level jobs of the family).
- 2. Assists program head with a variety of high-level administrative/professional program support responsibilities.
- 3. Coordinates program/services activities to ensure relevant guidelines, specifications, policy and/or procedures are enforced and followed.
- 4. Provides information to and facilitates communication between administrators, faculty, staff, and students concerning program/services.
- 5. Maintains relevant databases to ensure accurate and accessible records.
- 6. May coordinate and organize courses/classes to include activities such as student registration, room scheduling, and ensuring appropriate equipment is available.
- 7. Monitors budget and grant funding and ensures expenditures are within specifications and in line with spending projections; may research, write, submit, and/or administer grants and proposals for submission.
- 8. Prepares, reviews, and edits an assortment of communications through various media outlets.
- 9. Plans and implements the management of resource development activities.

Supervisory Responsibility

May be responsible for training, assisting or assigning tasks to others. May provide input to performance reviews of other employees.
