Job Summary

Advises, counsels, and creates programs tailored to first-year and incoming students relating to career choices, career development, and the college to career transition.

Essential Functions

- 1. Develops, administers, manages, and coordinates Career Center initiatives and educational programs for first-year and incoming students.
- 2. Provides individual and group career counseling to first year exploratory students; administers assessment instruments and computerized career guidance systems as warranted.
- 3. Provides individual and group career counseling to students and alumni on all aspects of career development, job search, and the college to career transition.
- Provides career development programming for Camp War Eagle, UNIV freshman courses, and in conjunction with the Office of Admissions and Recruitment and the Division of Student Affairs.
- 5. Develops and implements a variety of Career Center programs for incoming and first-year students, including, but not limited to, the Choosing Your Major workshops.
- 6. Works collaboratively with assigned academic liaison areas to promote Career Center programs and services while increasing student participation.

Supervisory Responsibility

May be responsible for training, assisting or assigning tasks to others. May provide input to performance reviews of other employees.

The above essential functions are representative of major duties of positions in this job classification. Specific duties and responsibilities may vary based upon departmental needs. Other duties may be assigned similar to the above consistent with the knowledge, skills and abilities required for the job. Not all of the duties may be assigned to a position.

- Under close supervision, performs varied duties and assignments involving some judgment. Resolves routine questions or problems, referring only complex issues to higher level. Some evaluation, originality and ingenuity required.
- Knows and applies fundamental concepts, practices, and procedures of particular field of specialization, with awareness of related fields.

Masters degree in discipline appropriate to position with no experience.

Under minimal supervision, performs complex assignments and fulfills broad responsibilities where required outcomes are defined, but methods and procedures may vary based on professional judgment or precedent. Considerable latitude for unreviewed action. Confers with supervisor on unusual matters. Coordinates the work of others on projects and may assign work to and assist less experienced professionals or support staff. May act in an advisory capacity to managers or faculty.

Possesses and applies a broad knowledge of principles, practices and procedures of a particular field of specialization to the completion of difficult assignments. Also possesses knowledge of related fields and areas of operation which affect, or are affected by, own area. Masters degree in discipline appropriate to position plus 2 years experience. Experience must include at least 2 years at the preceding level or equivalent.

Under general guidance, plans, Ш conducts and leads complex assignments and areas of functional responsibility. Acting with substantial latitude for unreviewed action, applies broad subject matter expertise to solution of significant issues or development of new programs, services, processes or other initiatives to meet the University's goals in a specific area. Recommends changes in procedures or policies, and leads change initiatives to completion, often persuading or coordinating work of others outside own department.

Possesses and applies comprehensive knowledge of a particular field of specialization to the completion of complex assignments. Also possesses strong knowledge of related fields, processes, policies or areas of operation which affect, or are affected by, own area.

Masters degree in discipline appropriate to position plus 4 years experience. Experience must include at least 2 years at the preceding level or equivalent.
