Job Summary

Assists with overseeing the sports nutrition program for student-athletes and the management of the Wellness Kitchen dining facility for Auburn University Athletics.

Essential Functions

- 1. Performs dietary assessments and counseling to student-athletes for all varsity sports.
- 2. Assists in the management of the Wellness Kitchen dining facility.
- 3. Performs nutrition education talks and demonstrations to teams.
- 4. Performs and analyzes body composition assessments of student-athletes.
- 5. Evaluates the use of dietary supplements by student athletes.
- 6. Plans travel nutrition and pre-game menus.
- 7. Conducts tours of off campus locations that specialize in student-athlete nutrition programs.
- 8. May coordinate and oversee student volunteer sports nutrition programs.
- 9. Complies with all applicable National Collegiate Athletic Association (NCAA) and Southeastern Conference (SEC) regulations in the performance of job duties.

Supervisory Responsibility

May be responsible for training, assisting or assigning tasks to others. May provide input to performance reviews of other employees.

Other duties may be assigned similar to the above consistent with the knowledge, skills and abilities required for the job. Not all of the duties may be assigned to a position.

Level I Bachelors degree in discipline appropriate to position with no experience.

Level II Bachelors degree in discipline appropriate to position plus 2 years experience. Experience

must include at least 2 years at the preceding level or equivalent.

Level III Bachelors degree in discipline appropriate to position plus 4 years experience. Experience

must include at least 2 years at the preceding level or equivalent.

Focus of Education Focus of Experience

Nutrition or related field. Experience in assisting, advising, or administering a college sports nutrition program

Substitutions allowed for Education:

Indicated education is required; no substitutions allowed.

Substitutions allowed for Experience:

When a candidate has the required education, but lacks the required experience, they may normally apply additional appropriate education toward the experience requirement, at a rate of one (1) year relevant education per year of required experience.

Minimum Required Knowledge
