Job Summary

Performs duties to include providing professional expertise in the operation of Auburn University environmental, safety and health programs to help ensure compliance with regulatory requirements, national consensus standards and the Auburn University Safety Policy. Areas of specialization: This job may specify responsibilities pertaining to professional competencies necessary for a more focused position specialization. These specializations are in the following areas: 1. Biological Safety. 2. Hazardous Materials. 3. Fire Protection. 4. Radiological Safety. 5. Laboratory Safety.

Essential Functions

- 1. May participate in the chemical spill emergency response team.
- 2. Provides technical guidance to the University community in relation to specialized area.
- 3. Develops and manages safety programs to prevent and correct unsafe working conditions.
- Develops and manages industrial hygiene programs to include analyzing and controlling conditions contributing to occupational hazards and disease, and determining safe limits of exposure to materials or conditions.
- 5. Designs, conducts and coordinates training and education in area of specialization.
- 6. Conducts inspections and evaluations, and recommends control measures.
- 7. Recommends actions and solutions for resolving/preventing violations.

Supervisory Responsibility

May supervise employees but supervision is not the main focus of the job.

The above essential functions are representative of major duties of positions in this job classification. Specific duties and responsibilities may vary based upon departmental needs. Other duties may be assigned similar to the above consistent with the knowledge, skills and abilities required for the job. Not all of the duties may be assigned to a position.

Minimum Required Education and Experience

Level I Bachelor's degree in discipline appropriate to position with no experience.

Level II Bachelor's degree in discipline appropriate to position plus 2 years experience.

Experience must include at least 2 years at the preceding level or equivalent.

Level III Bachelor's degree in discipline appropriate to position plus 4 years experience.

Experience must include at least 2 years at the preceding level or equivalent.

Degree in Environmental Science, Health and Safety, Industrial Hygiene, Biological Sciences, Engineering, Chemistry or a related field

Experience in health and safety regulatory compliance enforcement

Substitutions allowed for Education:

Certification or Licensure Requirements:

Some positions may require content specific certification and licensing.

Physical Requirements/ADA
