## **Job Summary**

Performs maintenance on airport facilities, grounds, service and refueling equipment and provides flight line services for local and transient aircraft.

#### **Essential Functions**

- Perform general maintenance on grounds, runways, taxiways and facilities equipment such as tractors, mowers, sweepers, sprayers lawn tractors, blowers, compressors, weed eaters, welders and pre-heaters.
- 2. Tests fuel quality using field test, api gravity test and Millipore test.
- 3. Participates in flight line activities such as loading, refueling, washing, towing, parking and crash control parking.
- 4. Provides facility and grounds maintenance.
- 5. Maintains airport vehicles which includes fueling and any maintenance required to ensure safety and service standards at all times.
- 6. Repairs equipment and fixtures at the airport, such as runway lighting, fixtures to regulators, and receivers/controllers.
- 7. Conducts security patrols and inspections on facilities, hangers and fence line.
- 8. Conducts test for water runoff to comply with Environmental Protection Agency regulations.
- 9. Trains student line service employees.

## **Supervisory Responsibility**

May be responsible for training, assisting or assigning tasks to others. May provide input to performance reviews of other employees.

The above essential functions are representative of major duties of positions in this job classification. Specific duties and responsibilities may vary based upon departmental needs. Other duties may be assigned similar to the above consistent with the knowledge, skills and abilities required for the job. Not all of the duties may be assigned to a position.
