### Job Summary

Oversees stage operation activities to include supervising student workers and construction of non-costume design elements.

### Essential Functions

1. Oversees and leads students and employees in the execution and construction of set and lighting designs.
2. Serves as lead carpenter and electrician for all season productions.
3. Oversees all non-Auburn University Theatre groups and personnel using Auburn University Theatre facilities, ensuring safety and compliance with policies and procedures.
4. Ensures the immediate safety of students and employees in accordance with shop safety standards.
5. Ensures the maintenance and availability of all tools and supplies.
6. Evaluates practicum students and provides feedback to faculty.

### Supervisory Responsibility

May supervise employees but supervision is not the main focus of the job.

### Minimum Required Education and Experience

- Level I** Bachelor's degree in discipline appropriate to position with no experience.
- Level II** Bachelor's degree in discipline appropriate to position plus 2 years experience. Experience must include at least 2 years at the preceding level or equivalent.
- Level III** Bachelor's degree in discipline appropriate to position plus 4 years experience. Experience must include at least 2 years at the preceding level or equivalent.

#### Focus of Education

Degree in Theatre or related field

#### Focus of Experience

Experience in technical theatre support or theatrical set construction.

#### Substitutions allowed for Education:

Indicated education is required; no substitutions allowed.

#### Substitutions allowed for Experience:

When a candidate has the required education, but lacks the required experience, they may normally apply additional appropriate education toward the experience requirement, at a rate of one (1) year relevant education per year of required experience.

### Physical Requirements/ADA

Regularly involves lifting, bending or other physical exertion. Often exposed to one or more elements such as heat, cold, noise, dust, dirt, chemicals, etc., with one often to the point of being objectionable. Injuries may require professional treatment.

Externally imposed deadlines; set or revised on short notice; frequent shifts in priority; numerous interruptions requiring immediate attention; unusual pressure on a daily basis due to accountability for success for major projects or areas of operation.

Job frequently requires standing, walking, reaching, talking, hearing, handling objects with hands, and lifting up to 100 pounds.

Job occasionally requires sitting, climbing or balancing, stooping/kneeling/crouching/crawling, and lifting more than 100 pounds.
