Job Summary

Provides support at the central level for extramural projects to include proposal development assistance, maintains and provides various research resources and information for faculty and staff, implementation and coordination of training and engagement programs, and coordinates activities related to the internal grants, awards, and incentive programs of the Office of the Vice President for Research and Economic Development.

Essential Functions

- 1. Evaluates incoming web-based and hard copy research and development opportunities and distributes to appropriate faculty and staff.
- 2. Advises faculty and staff on appropriate research resources to identify potential sources of program support.
- 3. Assists in the administration of education programs to implement regulations, policies and procedures for faculty, staff, and students including fostering the development of grantmanship skills of faculty researchers at all levels assuring consistency with institutional research and training goals.
- 4. Assists with the coordination of and participates in various engagement activities of the office including facilitation support for various meetings and committees.
- 5. Responsible for assisting faculty in generating effective and fundable extramural proposals through the facilitation of the proposal process from pre-RFP activities through all stages of proposal conceptual development.

Supervisory Responsibility

May be responsible for training, assisting or assigning tasks to others. May provide input to performance reviews of other employees.

The above essential functions are representative of major duties of positions in this job classification. Specific duties and responsibilities may vary based upon departmental needs.
