### Job Summary

Provides on-site supervision of specific preventive maintenance projects by managing secondary preventive maintenance shop functions as assigned by the supervisor of the preventive maintenance shop.

### Essential Functions

1. Provides technical advice and support to technicians and monitors the repairs of equipment and maintenance inspections.
2. Provides on-site supervision to work crews on all assigned maintenance, repairs and inspections.
3. Posts invoices, work orders, and oversees computer database for work activities, supplies, and equipment so that time and equipment is accounted for.
4. Assists with diagnosing problems, repairs and replaces parts and equipment and with electrical, plumbing, mechanical, welding and inspections.
5. Communicates with supervisor and others to keep them aware of activities within the department and to answer questions.

### Supervisory Responsibility

Full supervisory responsibility for other employees is a major responsibility and includes training, evaluating, and making or recommending pay, promotion or other employment decisions.

*The above essential functions are representative of major duties of positions in this job classification. Specific duties and responsibilities may vary based upon departmental needs. Other duties may be assigned similar to the above consistent with the knowledge, skills and abilities required for the job. Not all of the duties may be assigned to a position.*

## Physical Requirements/ADA

Frequent heavy or intense physical requirements, combined with exposure to a number of disagreeable elements, such as heat, cold, noise, dust, dirt, chemicals. Injury may require professional treatment or hospitalization. Constant precautions required.

Externally imposed deadlines; set and revised beyond one's control; interruptions influence priorities; difficult to anticipate nature or volume of work with certainty beyond a few days; meeting of deadlines and coordination of unrelated activities are key to position; may involve conflict-resolution or similar interactions involving emotional issues or stress on a regular basis.

Job frequently requires sitting, talking, hearing, handling objects with hands, and lifting up to 10 pounds.

Job occasionally requires standing, walking, reaching, climbing or balancing, stooping/kneeling/crouching/crawling, and lifting more than 100 pounds.

Vision requirements: Ability to see information in print and/or electronically.
