The Board of Trustees of Auburn University convened for a meeting on Friday, February 19, 2016, in the President's Office Board Room, 107 Samford Hall, Auburn University. President Pro Tempore Charles McCrary convened the meeting at 9:30 a.m. Upon roll call by Board Secretary Grant Davis, the following named members of the Board of Trustees were deemed to be in attendance:

The individuals listed above represent all persons recognized as members of the Board of Trustees of Auburn University at the time of the meeting. Other persons in attendance at the meeting included the following:

Mr. McCrary called upon Dr. Gogue who informed the Board that a request was before them to appoint Dr. Paul Patterson as the Director of the Alabama Agricultural Experiment Station. Dr. Gogue called upon Provost Boosinger who indicated that the Search Committee and the Faculty Senate both unanimously approve of this appointment. A motion to appoint Dr. Patterson as the Director of the Alabama Agricultural Experiment Station was received from Trustee Rane, seconded by Trustee Huntley and the Board unanimously approved the appointment as follows:

RESOLUTION

PROPOSED APPOINTMENT OF THE DIRECTOR
OF THE ALABAMA AGRICULTURAL EXPERIMENT STATION

WHEREAS, Board of Trustees By-Laws, consistent with State law, require that the Director of AAES shall be appointed by the President with approval of the Board of Trustees; and

WHEREAS, after a national search by a committee which included representatives of stakeholders in the agriculture industry both within the University and around the state, Dr. Paul Patterson was identified as the best candidate to lead the University's agricultural programs; and

WHEREAS, the President hereby requests the Board's approval of his appointment of Dr. Paul Patterson to the position of Director of the Alabama Agricultural Experiment Station.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Auburn University that the appointment of Dr. Paul Patterson as Director of the Alabama Agricultural Experiment Station is hereby approved.
