

- UnitedHealthcare is confident it is compliant with Medicare rules and is contesting the claims.
- UnitedHealthcare is proud to serve millions of Medicare Advantage members for well over 30 years.

The Alabama Securities Commission takes the lead to protect seniors from financial exploitation

he Alabama Securities Commission (ASC) is headquartered in Montgomery, Alabama. Director Joseph P. Borg, has been a state and international advocate for Alabama's "main street" investors and endeavors to protect Alabama citizens from deceptive and illegal practices associated with offers, sales and purchases of securities in Alabama. ASC provides fraud prevention education and outreach to our state's senior population to assist them to make informed financial decisions, successfully recognize and avoid financial scams, and to invest their personal financial assets wisely and safely so their retirement nest eggs stay secure.

ASC Accomplishments in 2016 Financial exploitation of senior Alabamians can be devastating, especially if the senior experiences some degree of cognitive decline, usually referred to as "diminished capacity," associated with the senior's lessened ability to adequately assess and manage their financial resources which can lead to increased susceptibility to financial abuse and exploitation. During 2016, ASC, with support from the Alabama Department of Human Resources, drafted and proposed to the Alabama Legislature, a bill entitled "Protection of Vulnerable Adults from Financial Exploitation Act" (SB220). Combined with an Alabama Senate version of the proposed bill, the act was signed into law on April 18, 2016, and became effective July 1, 2016 (Code of Ala., §8-6-170). The law strives to increase protections for seniors and other vulnerable adults by clarifying and better aligning the responsibilities of financial professionals, regulators, law enforcement and Adult Protective Services, with regard to the reporting of suspected or confirmed senior financial exploitation.

Innovative Activities to Enhance Wellbeing of Older Alabamians ASC Director, Joseph Borg, is a member of the North American Securities Administration's (NASAA) Board-level Committee, "Senior Issues/Diminished Capacity." Activities include coordinating national training events throughout NASAA membership in support of the "Senior\$afe Act" (HR4538); evaluate opportunities to work with other senior advocacy organizations to protect the interests of senior investors; research and develop innovative regulatory solutions to detect and prevent senior investor abuse; and develop reporting meth-

ods for use by state securities regulators to track reports of elder financial exploitation.

Past and On-going Efforts For the past several years, and continuing during 2016, ASC has maintained several successful financial education and outreach partnerships.

ADSS with Area Agencies on Aging-ASC offered valuable insight and educational materials to more than 350 working Alabama adults, retired seniors and professional caregivers to aid them and their families to successfully recognize and avoid potential elder financial fraud, exploitation and abuse. ASC helped secure generous grants from the Washington, D.C.-based Investor Protection Trust (IPT) to cosponsor 2016's WEAAD Elder Protection Seminar in Walker County. Approximately 420 seniors and caregivers heard timely presentations about the many facets of elder abuse and victimization from multiple regulatory, social and law enforcement agencies.

Alabama Gerontological Society (AGS)

The ASC, through a generous IPT grant, helped sponsor the 2016 AGS Conference. ASC Director, Joseph Borg, and ASC General Counsel, Amanda Senn, provided an accredited seminar about new legislation that provides investment professionals new tools to protect seniors, who may exhibit diminished capacity, from financial exploitation; and explanation of new reporting procedures to ASC and DHR.

Alabama Education Retirees Association (AERA)-Comprised of 81 local units in nine districts, serving approximately 25,000 retired Alabama educators. In 2016, ASC personnel visited nine chapters, presenting educational programs to 285 retired state educators.

Alabama Retired State Employees Association/Alabama Public Employees Advocacy League (ARSEA/APEAL)-Comprised of approximately 20,000 constituents representing state, county and municipal retirees. During 2016, ASC personnel made presentations and provided educational material to approximately 100 members about the many aspects of financial fraud/victimization that could threaten their retirement assets, and enhanced members' overall financial knowledge and preparedness. ASC also provided financial education information to more than 125 attendees at the organization's Annual Convention, held at Auburn University.

Alabama Cooperative Extension System (ACES)-ASC has partnered with ACES for the past nine years to help provide Estate Planning Seminars for Alabama retirees and those approaching retirement. Ten financial education programs were presented in 2016, with more than 250 individuals receiving insightful information about successfully recognizing and combating unsuitable investment "opportunities" and how financial fraud takes place.

Better Business Bureau (BBB) of North Alabama-Building upon a 13-year partnership, ASC assisted to obtain IPT grants to co-sponsor Fraud Prevention Summits in Huntsville, Decatur, Athens, Cullman and Sumiton. More than 870 working adults and retirees attended these events organized around expert panels of representatives from the BBB of North Alabama, ASC, Alabama Attorney General's Consumer Affairs Division, U.S. Postal Inspection Service, U.S. Federal Trade Commission, area financial institutions and law enforcement agencies.

Achievements ASC is an active member of The Alabama Interagency Council for the Prevention of Elder Abuse. The Council's mission is to strengthen partnerships to protect seniors and raise awareness of elder abuse issues through education, advocacy and outreach. ASC partners with local Area Agencies on Aging to co-sponsor senior education/outreach events funded through Investor Protection Trust grants. During 2016, approximately 430 senior Alabamians were reached through educational "Senior Summit" events in Pelham, Montgomery, Phenix City, Huntsville and Luverne.

Measurable Results Financial abuse targeting seniors is estimated to cost more than \$2.9 billion annually (MetLife Mature Markets Institute). During 2016, ASC Enforcement and Legal Division personnel secured 14 convictions for financial fraud. in which 19 senior Alabamians were targeted. ASC actions resulted in the Courts ordering \$837,356 in rescissions (civil or administrative penalties) and \$5,908,670 in victim restitution (criminal penalties) from defendants convicted of defrauding our citizens. ASC continues to conduct investor education and fraud prevention outreach seminars across the state. In 2016, 78 seminars were held, reaching 6,797 citizens.

2017 Recipient of the Wilford S. Bailey Award – Mr. Joseph P. Borg



oseph Borg has been Director of the Alabama Securities Commission (ASC) since 1994. Borg was twice past president of the North American Securities Administrators Association (NASAA) and is currently President-elect. He served as a member on the NASAA Board of Directors, as Chair of the International Committee and as Chair of Enforcement. He is also a member of the Board of Directors

of the National White Collar Crime Center (NW3C) and previously served as a member of the Board of Directors of the Investor Protection Trust (IPT).

Borg has testified before various committees of the U.S. Senate and U.S. House of Representatives including testimony on such areas as Microcap fraud: Criminal elements in the financial markets; Information sharing among financial regulatory agencies; Risks posed



everyday investors from IPOs in private equity and hedge funds; Illegal investment sales' practices victimizing senior citizens; and GSEs and SIPC Modernization. He has also served as a member of the SIPC Modernization Task Force and the FINRA Dispute Resolution Task Force.

Borg served as a U.S. delegate to an Intergovernmental Expert Group for the United Nations Commission on International Trade and Law (UNCITRAL).

Borg previously served as in-house corporate counsel to First Alabama Bank (n/k/a Regions Bank, 1979-1984) and has been an adjunct professor of law at Faulkner University Jones School of Law teaching securities law and banking (1982-2002), and has been a Partner in the Montgomery law firm of Capouano, Wampold, Prestwood & Sansone (1984-1994).


He is admitted to practice in Alabama, Florida, New York, U.S. Federal District Courts in Alabama and Florida, the 5th and 11th Circuit Courts of Appeal and the U.S. Supreme Court.

"Education Budget and AURA bills of interest pending in Legislature"

In the winter issue of the AURA Newsletter, the AURA Legislative Affairs Committee reported that AERA, AURA, and the education retiree community, were better prepared for the 2017 legislative session than for any session over the past decade. The session began with a commitment that retirees will be the number one priority for inclusion in the



FY 18 budget. Legislation to provide a COLA in the form of a 13th Check based on a formula of \$24 times years of service with a minimum, was introduced. Legislation to establish a COLA Trust Fund was introduced.

The Alabama Legislature returned to work April 4th, after a two week spring break, for the 14th day of the 30 day maximum session, to address a number of issues, including its two major items, the General Fund and Education Trust Fund budgets. Before the spring break the House of Representatives passed a \$1.8 billion General Fund budget and that is now in the Senate. However, the Senate still has the ETF budget and that will probably be addressed first when the Senate reconvenes. Not included in the ETF budget at this point are the two items of highest interests to AURA members--the 13th Check and the COLA Trust Fund.

However, the budgets are not the only items on the legislative agenda. To date, 774 bills have been introduced in this session. Bills on the docket include prison construction, redistricting, impeachment, jury sentence override, day care licensing, health insurance coverage for autism related illnesses, protection of historical monuments, Medicaid, Lottery, permit-less gun carry, faith base adoption regulation, fuel tax, school choice, moral turpitude bill that would result in the loss of the right to vote, regulation of fantasy sports contest, establish a State Board of Midwifery and allow carrying of firearms by school personnel on school property. Most of these bills will not be enacted into law but they each may become an important part of the complex legislative process through which some bills become law.

The legislation to provide a COLA in the form of a 13th Check and to establish a COLA Trust Fund are parts, probably minor parts, of the total legislative agenda. Thus, AURA has activated its Legislative Affairs Committee and, in collaboration with AERA, has established a Local Advocacy Network to participate in advocating for passage of these two bills. As called upon, the active participation of AURA members, and all education retirees, in advocating for these bills can make the difference in the final disposition of these two measures. This is how the democratic representative process works.
