General Scholarships

Requirements

Eligible students are automatically considered for any General Scholarship for which they meet the criteria. Unless otherwise noted, recipients are selected by the Office of University Scholarships. General Scholarships are awarded competitively in early April at varying amounts, and consideration does not guarantee a scholarship will be awarded. The minimum academic requirements for consideration are as follows:

- Incoming freshmen — Accepted for admission and a minimum 3.0 high school GPA
- Transfer students — Accepted for admission by February 1 and a minimum 3.0 transfer GPA
- Current students — Minimum 3.0 cumulative, unadjusted AU GPA following fall semester

Priority consideration is given to incoming freshmen who meet the Freshman Scholarship priority deadline of December 1 and have not previously been recognized with a scholarship valued at resident tuition or greater. Students with a test score at or above the average test score of Auburn's most recent freshman class are more likely to receive an award.

To receive consideration for need-based scholarships, students should complete the Free Application for Federal Student Aid (FAFSA), available online beginning January 1. The FAFSA must be received by Auburn University by the financial aid priority deadline of March 1.

Criteria

Criteria for General Scholarships include but are not limited to geography, class standing, academics, financial need, and/or affiliation with a particular organization. General Scholarships are awarded competitively at an average award amount of \$1,500 for one year. Approximately 50% of General Scholarships give preference to incoming freshmen, and approximately 50% of them give preference to students who demonstrate financial need.

Autauga County Auburn Club/Ronnie Rucker Memorial Endowed Scholarship — Must be a graduate of an Autauga County high school and demonstrate financial need.

Baldwin County Auburn Club Endowed Scholarship — Must be a graduate of a Baldwin County high school, demonstrate academic excellence, and demonstrate financial need.

Blount County Auburn Club Annual Scholarship — Must be a resident and a graduate of a Blount County high school and demonstrate academic excellence, with preference given to an incoming freshman who demonstrates financial need.

Calhoun/Cleburne Counties Auburn Club Endowed Scholarship — Must be a graduate of a Calhoun or Cleburne County high school and demonstrate academic excellence.

Cherokee County Auburn Club/Robert Leath Memorial Annual Scholarship — Must be a resident and a graduate of a Cherokee County high school, demonstrate academic excellence, and demonstrate financial need.

Chilton County Auburn Club Annual Scholarship — Must be an incoming student, a graduate of a Chilton County high school, demonstrate academic excellence, and demonstrate financial need.

Columbus/Phenix City Auburn Club Annual Scholarship — Preference given to incoming students who have a parent or guardian who is an Auburn alumnus; are residents and graduates of a high school in the Columbus/Phenix City area, as defined by the Columbus/Phenix City Auburn Club; and demonstrate financial need.

Crenshaw County Auburn Club Annual Scholarship — Must be an incoming freshman, be a graduate of a Crenshaw County high school, demonstrate academic excellence, and demonstrate financial need.

Cullman County Auburn Club/Herman T. Pruett Memorial Annual Scholarship — Must be an incoming freshman, be a graduate of a Cullman County high school, and demonstrate academic excellence.

Dale County Auburn Club/Pamela Wells Sheffield Annual Scholarship — Must be a graduate of Carroll High School in Ozark or a Dale County high school, as defined by the Dale County Auburn Club, and demonstrate financial need.

Dekalb County Auburn Club/Lala Prewett "War Eagle" Endowed Scholarship
Must be a graduate of Fort Payne High School and demonstrate academic excellence.

Elmore County Auburn Club Endowed Scholarship — Must be a resident and a graduate of an Elmore County high school, demonstrate academic excellence, and demonstrate financial need.

Escambia County Auburn Club Endowed Scholarship — Preference given to an incoming freshman who is a graduate of an Escambia County high school and demonstrates academic excellence.

Etowah County Auburn Club Annual Scholarship — Must be a resident of Etowah County, demonstrate academic excellence, and demonstrate financial need.

Greater Birmingham Auburn Club Annual Band Scholarship — Must be a graduate of a Jefferson or Shelby County high school, demonstrate musical ability as determined through an audition before the Director of Bands, demonstrate academic excellence, and demonstrate financial need.

Greater Birmingham Auburn Club/Jimmy Brown Memorial Endowed Scholarship — Must be a graduate of a Jefferson County high school and demonstrate academic excellence.

Greater Birmingham Auburn Club/Howard Elliott Memorial Endowed Scholarship — Must be a resident and a graduate of a Shelby County high school and have a minimum 29 ACT or 1290 SAT score. Preference given to incoming freshmen and transfer students who demonstrate financial need.

Greater Birmingham Auburn Club/Jim Scogin Memorial Endowed Scholarship — Must be an incoming freshman awarded a Spirit of Auburn Scholarship, with preference given to a graduate of a Jefferson or Shelby County high school who demonstrates financial need.

Greater Birmingham Auburn Club/Edd Wadley Endowed Scholarship — Must be a graduate of a Jefferson County high school and demonstrate academic excellence.

Greater Valley Area Auburn Club Annual Scholarship — Must demonstrate academic excellence with preference given to an incoming freshman who is a resident of the Greater Valley area, as defined by the Greater Valley Area Auburn Club.

Guntersville/Marshall County Auburn Club Endowed Scholarship — Preference given to incoming freshmen who are residents of Marshall County, are graduates of Guntersville High School, have lettered in a high school sport at the varsity level, and demonstrate financial need.

Henry County Auburn Club Annual Scholarship — Must demonstrate academic excellence with preference given first to graduates of Headland High School or Abbeville High School and then to graduates of all Henry County high schools.

Huntsville Madison County Auburn Club/Brooks and Marian Moore Endowed Scholarship — Must be an incoming freshman, have a minimum 24 ACT or 1090 SAT score and a 3.5 high school GPA, and be a resident of Madison County, with preference given to a dependent of an Auburn alumnus who demonstrates financial need.

Jackson County Auburn Club Annual Scholarship — Must be an incoming freshman, be a resident and a graduate of a Jackson County high school, and demonstrate academic excellence.

Lee County Auburn Club Endowed Scholarship — Must be a graduate of a Lee County high school. A maximum of one student per high school is awarded.

Limestone County Auburn Club Endowed Scholarship — Must be a graduate of an Athens city or Limestone County high school and demonstrate academic excellence.

Marshall County Auburn Club Annual Scholarship — Preference given to incoming students who are residents and graduates of a Marshall County high school and demonstrate financial need. A maximum of one student per high school is awarded.

Marshall County Auburn Club Endowed Scholarship — Must be a resident and graduate of a Marshall County high school, with preference given to incoming freshmen and transfer students who demonstrate financial need. Incoming freshmen must have a minimum 29 ACT or 1290 SAT.

Marshall County Auburn Club/Jerry Mack Whitaker Memorial Endowed Scholarship — Preference given to a student who is a graduate of Guntersville high school who demonstrates financial need.

Mobile County Auburn Club Annual Scholarship — Must be an incoming freshman, be a graduate of a Mobile County high school, demonstrate academic excellence, and demonstrate financial need.

Mobile County Auburn Club/Dr. Edmund Dyas Memorial Endowed Scholarship — Must be an incoming freshman awarded a Spirit of Auburn University Scholarship, with preference given to a graduate of a high school in Mobile County who demonstrates financial need.

Mobile County Auburn Club/Dwain Luce Endowed Scholarship — Must be a resident and a graduate of a high school in Mobile County and have a minimum 29 ACT or 1290 SAT score. Preference given to incoming freshmen and transfer students who demonstrate financial need.

Monroe County Auburn Club Annual Scholarship — Preference given to an incoming freshman who is a resident and a graduate of a Monroe County high school.

Montgomery Auburn Club/Monty Carpenter Endowed Scholarship — Must be a graduate of a high school in Montgomery or Crenshaw County, with preference given to a student enrolled in pre-pharmacy who demonstrates financial need.

Montgomery County Auburn Club Endowed Scholarship — Must be an incoming freshman, be a graduate of a Montgomery County high school, demonstrate academic excellence, and demonstrate financial need.

North Alabama Auburn Club/Lloyd and Sandy Nix Annual Scholarship — Must be a graduate of a Morgan, Limestone, or Lawrence County high school with preference given to a student who demonstrates financial need.

Northwest Auburn Club Annual Scholarship — Must demonstrate academic excellence with preference given to transfer students who are residents and graduates of a high school in Fayette, Lamar, Marion, or Winston County and demonstrate financial need.

Randolph County Auburn Club Annual Scholarship — Must be a graduate of a Randolph County high school with preference given to a student who demonstrates financial need.

Shoals Area Auburn Club Endowed Scholarship — Preference given to a graduate of a Colbert or Lauderdale County high school with a 3.5 high school GPA who is a dependent of an Auburn alumnus.

South Talladega County Auburn Club Endowed Scholarship — Must be an incoming freshman; be a graduate of a high school in the South Talladega area, as defined by the South Talladega Auburn Club; and demonstrate academic excellence.

St. Clair County Auburn Club/Marlin S. and Amelia P. Hughins Annual Scholarship — Must demonstrate academic excellence with preference given to an incoming freshman who is a resident and a graduate of a St. Clair County high school.

St. Clair County Auburn Club/W.D. Jackson Memorial Annual Scholarship — Must demonstrate academic excellence with preference given to an incoming freshman who is a resident and a graduate of a St. Clair County high school and demonstrates financial need.

St. Clair County Auburn Club/Gray Jones Memorial Annual Scholarship — Must demonstrate academic excellence with preference given to an incoming freshman who is a resident and a graduate of a St. Clair County high school and demonstrates financial need.

Walker County Auburn Club/Sam Ross Murphy and Lawson W. Murphy, Jr. Endowed Scholarship — Must be an incoming freshman, be a graduate of a Walker County high school, and demonstrate academic excellence.

Wiregrass Auburn Club Annual Scholarship — Must be an incoming freshman and a resident of the Wiregrass area (Alabama, Georgia, or Florida), as defined by the Wiregrass Auburn Club, demonstrate academic excellence, and demonstrate financial need.

Wiregrass Auburn Club Endowed Scholarship — Must be an incoming freshman awarded a Spirit of Auburn Presidential Scholarship and a graduate of a high school in the Wiregrass area, as defined by the Wiregrass Auburn Club, with preference given to students who demonstrate financial need.

Florida Auburn Club Scholarships

Bay Area Auburn Club Annual Scholarship — Must be a resident and a graduate of a Bay area high school or a transfer student from a Bay area junior college, as defined by the Bay Area Auburn Club.

Emerald Coast Auburn Club/Bill and Gayle Creamer Memorial Endowed Scholarship — Must be a graduate of an Okaloosa or Walton County, Florida high school and demonstrate academic excellence.

Florida West Coast Auburn Club/JoAnn Davis Thorpe Annual Scholarship — Must be a resident and graduate of a Sarasota or Manatee County, Florida high school and demonstrate academic excellence.

Gold Coast, FL Auburn Club/Jorge Ignacio Portela Memorial Annual Scholarship — Must be a resident and a graduate of a Gold Coast area high school, as defined by the Gold Coast, Florida Auburn Club. Transfer students must have a 3.5 transfer GPA.

Jacksonville Auburn Club Annual Scholarship — Must be a resident of Clay, Duval, Nassau, or St. Johns County, Florida; be a dependent of an Auburn alumnus who is a life member of the Auburn Alumni Association; and demonstrate academic excellence.

Orlando Area Auburn Club Annual Scholarship — Must be an incoming freshman; be a graduate of an Orlando area high school, as defined by the Orlando Area Auburn Club; and demonstrate financial need.

Tallahassee Auburn Club Endowed Scholarship — Must demonstrate academic excellence with preference given to an incoming freshman or current recipient who is a graduate of a Leon County, Florida high school.

Tampa Bay Auburn Club/Prentis S. Howard Endowed Scholarship — Must be a graduate of a Hillsborough County, Florida high school and demonstrate academic excellence.

Auburn Club of West Florida Annual Scholarship — Must be an incoming freshman, be a resident and graduate of an Escambia or Santa Rosa County, Florida public high school, and demonstrate academic excellence.

Wiregrass Auburn Club Annual Scholarship — Must be an incoming freshman and a resident of the Wiregrass area (Alabama, Georgia, or Florida), as defined by the Wiregrass Auburn Club, demonstrate academic excellence, and demonstrate financial need.

Georgia Auburn Club Scholarships

Atlanta Auburn Club Endowed Scholarship — Must be from the metropolitan Atlanta area, as defined by the Atlanta Auburn Club, have a minimum 28 ACT or 1250 SAT score, and demonstrate financial need, with preference given to an incoming freshman or transfer student.

Atlanta Auburn Club/Roy B. Sewell Memorial Annual Scholarship — Must be from the metropolitan Atlanta area, as defined by the Atlanta Auburn Club, have a minimum 29 ACT or 1290 SAT score, and demonstrate financial need, with preference given to a dependent of an Auburn alumnus.

Columbus/Phenix City Auburn Club Annual Scholarship — Preference given to incoming students who have a parent or guardian who is an Auburn alumnus; are residents and graduates of a high school in the Columbus/Phenix City area, as defined by the Columbus/Phenix City Auburn Club; and demonstrate financial need.

Coweta/Fayette Auburn Club Annual Scholarship — Must be a resident of Coweta County or Fayette County, Georgia and demonstrate academic excellence, with preference given to a student who demonstrates financial need.

Coweta/Fayette Auburn Club/Whupper Lee Endowed Scholarship — Must be a resident and graduate of a high school in Coweta or Fayette County, Georgia, with preference given to a student who demonstrates financial need.

Golden Isles Auburn Club Annual Scholarship — Must be an incoming freshman, be a resident of Glynn County, Georgia, and demonstrate academic excellence, with preference given to a student who demonstrates financial need.

Greater Valley Area Auburn Club Annual Scholarship — Must demonstrate academic excellence with preference given to an incoming freshman who is a resident of the Greater Valley area, as defined by the Greater Valley Area Auburn Club.

Lanierland Auburn Club Annual Scholarship — Must be an incoming freshman with preference given to graduates of a high school in the Lanierland area, as defined by the Lanierland Auburn Club, who demonstrate financial need.

McIntosh Area Auburn Club Annual Scholarship — Must demonstrate academic excellence with preference given to an incoming freshman who is a resident and a graduate of the McIntosh area, as defined by the McIntosh Area Auburn Club.

Middle Georgia (Macon) Auburn Club Annual Scholarship — Must be an incoming freshman; be a graduate of a high school in the Middle Georgia area, as defined by the Middle Georgia Auburn Club; demonstrate academic excellence; and demonstrate financial need.

Savannah Auburn Club Annual Scholarship — Must demonstrate academic excellence with preference given to an incoming freshman who is a resident of the Savannah area, as defined by the Savannah Auburn Club.

Southwest Georgia Auburn Club Annual Scholarship — Must be an incoming freshman from the Southwest Georgia area, as defined by the Southwest Georgia Auburn Club.

Southwest Georgia Auburn Club/Elmer Cleve Wester, Jr. Endowed Scholarship — Must be a graduate of a high school from the Southwest Georgia area, as defined by the Southwest Georgia Auburn Club, with preference given to a student who demonstrates financial need.

West Central Georgia Auburn Club Annual Scholarship — Must be an incoming freshman; be a graduate of a West Central Georgia high school, as defined by the West Central Georgia Auburn Club; and demonstrate academic excellence.

West Georgia Auburn Club/Charles D. Hudson Endowed Scholarship — Must be a resident of Harris, Meriwether, or Troup County, Georgia with preference given to students who demonstrate financial need and are dependents of an Auburn alumnus and a current member of the Auburn Alumni Association. Incoming freshmen must have a 26-29 ACT or 1170-1320 SAT score and a 3.0-3.5 high school GPA.

Wiregrass Auburn Club Annual Scholarship — Must be an incoming freshman and a resident of the Wiregrass area (Alabama, Georgia, or Florida), as defined by the Wiregrass Auburn Club, demonstrate academic excellence, and demonstrate financial need.

Tennessee Auburn Club Scholarships

Greater Nashville, TN Auburn Club Annual Scholarship — Must be a resident and a graduate of a high school in the Greater Nashville area, as defined by the Greater Nashville Auburn Club.

Greater Nashville, TN Auburn Club Endowed Scholarship — Must be a resident and a graduate of a high school in the Greater Nashville area, as defined by the Greater Nashville Auburn Club.

Memphis Area Auburn Club Annual Scholarship — Must be a resident and a graduate of a high school from the Memphis area, as defined by the Memphis Area Auburn Club, with preference given to an incoming student who demonstrates financial need.

Smoky Mountain Auburn Club Annual Scholarship — Be a resident and a graduate of the Smoky Mountain Tennessee area, as defined by the Smoky Mountain Auburn Club; be a dependent of an Auburn alumnus who is a life member of the Auburn Alumni Association; and demonstrate academic excellence.

Other Auburn Club Scholarships

Austin Auburn Club Annual Award — Must be an incoming freshman with a minimum 27 ACT or 1210 SAT score. Preference given to residents of Austin, TX, or the Austin Metropolitan Area, as defined by the Austin Auburn Club, who demonstrates financial need.

Baton Rouge Auburn Club Annual Scholarship — Must be a resident of the Baton Rouge, Louisiana area, as defined by the Baton Rouge Auburn Club.

Bluegrass (KY) Auburn Club Annual Scholarship — Must be a resident and a graduate of a high school in Kentucky and demonstrate academic excellence, with preference given to students who demonstrate financial need.

Cape Fear (NC) Auburn Club Annual Scholarship — Must be a resident of North Carolina; be a graduate of a Brunswick, New Hanover, or Pender County high school; and demonstrate academic excellence, with preference given to an incoming freshman who demonstrates financial need.

Central Mississippi Auburn Club Annual Award — Must be an incoming freshman with a minimum 27 ACT or comparable SAT score, with preference given to a resident from the Central Mississippi area, as defined by the Central Mississippi Auburn Club, who demonstrates financial need.

Charlotte Auburn Club Annual Scholarship — Must be a resident and a graduate of a high school in Cabarrus, Catawba, Gaston, Iredell, Lincoln, Mecklenburg, Rowan, or Union County, North Carolina or York County, South Carolina, with preference given to an incoming freshman who demonstrates financial need.

Chicago Auburn Club Annual Scholarship — Must be a resident of the Chicago Metropolitan Area as defined by the Chicago Auburn Club.

Columbia-Midlands Auburn Club Endowed Scholarship — Must demonstrate academic excellence with preference given to an incoming freshman who is a graduate of a high school in the Columbia-Midlands, South Carolina area, as defined by the Columbia-Midlands Auburn Club.

Golden Triangle Auburn Club Annual Scholarship — Must demonstrate academic excellence with preference given to incoming students who are residents and graduates of a Clay, Lowndes, Oktibbeha, Webster, or Winston County, Mississippi high school and demonstrate financial need.

Houston Area Auburn Club Annual Scholarship — Must demonstrate academic excellence with preference given to an incoming freshman from the Houston, Texas area, as defined by the Houston Area Auburn Club.

Kansas City Auburn Club Annual Scholarship — Must be a resident of the Greater Metro Kansas City Area as defined by the Kansas City Auburn Club, with preference given to a student who demonstrates financial need.

Lowcountry Auburn Club Annual Scholarship — Must be a resident and a graduate of a Berkley, Charleston, or Dorchester County, South Carolina high school and demonstrate academic excellence, with preference given to incoming students who demonstrate financial need.

New Orleans Auburn Club Annual Scholarship — Must be a resident of Louisiana and a graduate of a high school in the New Orleans, Louisiana area, as defined by the New Orleans Auburn Club, with preference given to students who demonstrate financial need.

Metro-Washington Auburn Club Endowed Scholarship — Must be a resident of the Metro-Washington D.C. area, as defined by the Metro-Washington Auburn Club, and demonstrate academic excellence.

Oklahoma City Auburn Club Annual Scholarship — Must demonstrate academic excellence with preference given to a resident and a graduate of a high school in the Oklahoma City, Oklahoma area, as defined by the Oklahoma City Area Auburn Club, who demonstrates financial need.

Oklahoma City Auburn Club/Jim Harkins Memorial Annual Award — Must be a resident of the Oklahoma City Metro area as defined by the Oklahoma City Auburn Club, with preference given to a student who demonstrates financial need.

Palmetto (Greenville, SC) Auburn Club Annual Scholarship — Preference given to an incoming freshman who is a graduate of a Palmetto area high school, as defined by the Palmetto (Greenville, SC) Auburn Club, and demonstrates financial need. Incoming freshmen must have a minimum 28 ACT or 1250 SAT score.

Philadelphia Auburn Club Annual Scholarship — Must be a resident and a graduate of a high school in the Philadelphia, Pennsylvania area, as defined by the Philadelphia Auburn Club, and demonstrate academic excellence, with preference given to an incoming student who demonstrates financial need.

Richmond Area Auburn Club Annual Scholarship — Must demonstrate academic excellence and be a resident and a graduate of a high school in the Richmond, Virginia area, as defined by the Richmond Area Auburn Club. Preference given to an incoming freshman who demonstrates financial need and has not received a full-tuition scholarship.

Rocky Mountain Auburn Club Annual Scholarship — Must be a graduate of a Colorado high school and demonstrate academic excellence.

San Diego Auburn Club Annual Scholarship — Preference given to a student who is a graduate of a high school in San Diego County, California and demonstrates financial need.

St. Louis, Missouri Auburn Club Annual Scholarship — Must demonstrate academic excellence with preference given first to a resident of the St. Louis, Missouri area and then to a student from the State of Missouri who demonstrates financial need.

Alabama Resident Scholarships

Les and Civel Adams Annual Scholarship — Preference given to a graduate of a Mobile County high school who demonstrates financial need.

Albertville High School Endowed Scholarship — Must be a graduate of Albertville High School with preference given to students who demonstrate financial need.

Muriel and Mary Lee Albright Endowed Scholarship — Must be a graduate of Brewer, Fairview, Holly Pond, or Arab High School with preference given to students who demonstrate financial need.

Auburn Parent's Association Spirit of Auburn Endowed Scholarship

Must be an incoming freshman awarded a Spirit of Auburn Scholarship, with preference given to a student who demonstrates financial need.

Auburn Rotary Club Endowed Scholarship— Must be an incoming freshman awarded a Spirit of Auburn Founders Scholarship, with preference given to a graduate of Auburn High School or Lee-Scott Academy in Auburn, Alabama, who demonstrates financial need.

Auburn University Retirees Association Annual Scholarship — Must be an Alabama resident, demonstrate financial need, and be a non-traditional incoming student or transfer student. Incoming freshman must have a minimum 25 ACT or 1130 SAT score and a 3.5 high school GPA. Transfer students must have completed at least two years of higher education and have a minimum 3.5 transfer GPA.

Auburn Veterans Endowed Scholarship — Must be a uniformed U.S. Military service member on active duty, inactive reserves, or honorably discharged from the U.S. armed forces and a current resident of Auburn, or a dependent of a uniformed U.S. Military service member on active duty, inactive reserves, or honorably discharged from the U.S. armed forces and a graduate of a high school in Lee County. Preference given to students who demonstrate financial need. Incoming freshmen must have a 23 ACT score or the comparable SAT score. Requires a copy of the DD-214 Form (Report of Separation) and proof of student's legal dependency as defined by IRS code.

James J. Baird, Jr. Endowed Scholarship

Must be an incoming freshman awarded a Spirit of Auburn University Scholarship or Academic Charter Scholarship, with preference given to a student who demonstrates financial need.

Charles E. Ball, Sr. Memorial Annual Scholarship — Preference given to students from the 5th Congressional District of Alabama who demonstrate financial need.

Mildred and Leonard Barstis Endowed Scholarship — Must be an Alabama resident and demonstrate financial need.
