JOB SUMMARY

This position serves as the manager for Youth Livestock Education Programs. This position directs and leads youth livestock educational programs for the Department of Animal Sciences, develops and delivers educational content for youth livestock education programs, manages volunteer and communication efforts with youth livestock program volunteers, and provides organizational leadership for on-campus youth livestock events while serving as liaison between Auburn University and key industry partners of the program.

RESPONSIBILITIES

- Program management and leadership - Leads and manages programs that engage youth in livestock management, care, and production systems (including 10 to 15 statewide youth livestock events per year).
- Volunteer management - Develops and conducts volunteer management for youth livestock activities. Work with volunteers to deliver youth education initiatives, coordinate events, and ensure the integration of best practices in livestock management across youth programs.
- Content creation and education - Creates content for educational programs for youth livestock that can be utilized by stakeholder groups such as 4-H, Alabama Cattlemen's Association, and the Alabama Farmers Federation. Conducts train-the-trainer trainings for these organizations.

The responsibilities listed above show the typical duties for jobs in this classification. Actual tasks may differ depending on the department's needs. Other similar duties may be assigned with discretion of the supervisor. Not every duty will apply to every position, and the amount of time spent on each task can change based on department needs.
