Job Summary

Directs an integrated approach to student athlete rehabilitation and provides long-term rehabilitative care.

Essential Functions

1. Provides administrative oversight for the Auburn Athletics Rehabilitation Department including fiscal management.
2. Oversees rehabilitation of and provides physical therapy to student athletes.
3. Coordinates rehabilitative care of student athletes with various related clinical staff to include athletic trainers.
4. Consults and assists with rehabilitation at designated rehabilitation sites.
5. Ensures appropriate levels of rehabilitation personnel are available for student athletes.
6. Complies with all applicable National Collegiate Athletic Association (NCAA) and Southeastern Conference (SEC) regulations in the performance of job duties.

Supervisory Responsibility

May supervise employees but supervision is not the main focus of the job.

The above essential functions are representative of major duties of positions in this job classification. Specific duties and responsibilities may vary based upon departmental needs. Other duties may be assigned similar to the above consistent with the knowledge, skills and abilities required for the job. Not all of the duties may be assigned to a position.

Minimum Required Knowledge

Knowledge of rehabilitative and physical therapy techniques and treatment plans.

Certification or Licensure Requirements

Certification as a Physical Therapist

Physical Requirements/ADA

Occasional and/or light lifting required. Limited exposure to elements such as heat, cold, noise, dust, dirt, chemicals, etc., but none to the point of being disagreeable. May involve minor safety hazards where likely result would be cuts, bruises, etc.

Externally imposed deadlines; set and revised beyond one's control; interruptions influence priorities; difficult to anticipate nature or volume of work with certainty beyond a few days; meeting of deadlines and coordination of unrelated activities are key to position; may involve conflict-resolution or similar interactions involving emotional issues or stress on a regular basis.

Job frequently requires standing, reaching, talking, hearing, handling objects with hands, .

Job occasionally requires walking, sitting, stooping/kneeling/crouching/crawling, and lifting up to 25 pounds.

Vision requirements: Ability to see information in print and/or electronically.
