### Job Summary

Coordinates, plans, and organizes programs and procedures for Auburn University athletic events.

### Essential Functions

1. Creates and oversees all assigned event staffing plans that are comprehensive, fiscally responsible, and customer service oriented.
2. Serves as the point of contact for all event management aspects of assigned sports and events.
3. Coordinates with others, internally and externally, to ensure that event needs are communicated, coordinated, and executed seamlessly.
4. Assists in the creation of the Auburn Arena manuals including but not limited to facility and technical guide, customer service training manual, Emergency Evacuation Plan, standard operation procedures, etc.
5. Ensures assigned athletic events are conducted in accordance with university, local, federal, National Collegiate Athletic Association (NCAA), and Southeastern Conference (SEC) rules and regulations.
6. Complies with all applicable NCAA and SEC regulations in the performance of job duties.

### Supervisory Responsibility

May be responsible for training, assisting or assigning tasks to others. May provide input to performance reviews of other employees.

Other duties may be assigned similar to the above consistent with the knowledge, skills and abilities required for the job. Not all of the duties may be assigned to a position.*

Considerable latitude for unreviewed action. Confers with supervisor on unusual matters. Coordinates the work of others on projects and may assign work to and assist less experienced professionals or support staff. May act in an advisory capacity to managers or faculty.	Possesses and applies a broad knowledge of principles, practices and procedures of a particular field of specialization to the completion of difficult assignments. Also possesses knowledge of related fields and areas of operation which affect, or are affected by, own area.	Bachelor's degree in discipline appropriate to position plus 4 years experience. Experience must include at least 2 years at the preceding level or equivalent.

### Minimum Required Education and Experience

- Level I** Bachelor's degree in discipline appropriate to position with no experience.
- Level II** Bachelor's degree in discipline appropriate to position plus 2 years experience. Experience must include at least 2 years at the preceding level or equivalent.
- Level III** Bachelor's degree in discipline appropriate to position plus 4 years experience. Experience must include at least 2 years at the preceding level or equivalent.

#### Focus of Education

Degree in Management, Business Administration, Sports Administration or related field

#### Focus of Experience

Experience in event planning and event budgeting

#### **Substitutions allowed for Education:**

Indicated education is required; no substitutions allowed.

#### **Substitutions allowed for Experience:**

When a candidate has the required education, but lacks the required experience, they may normally apply additional appropriate education toward the experience requirement, at a rate of one (1) year relevant education per year of required experience.

#### **Certification or Licensure Requirements:**

None Required.

### Physical Requirements/ADA
