JOB SUMMARY

Reporting to the Golf Facility Superintendent, the Athletic Golf Grounds Technician provides maintenance and landscaping services for athletics golf course.

RESPONSIBILITIES

- Performs maintenance and upkeep relative to the care, maintenance, protection, and preservation of the golf course grounds including greens, tees, fairways, bunkers, and surrounding out of play areas. Maintains and upkeeps the landscaping around the golf course ground to include weed eating, edging paths, edging heads and valves, and other related duties.
- Manicures different types and heights of cuts including: greens, tees, fairways, and roughs.
- Maintains the irrigation system upkeep and maintenance.
- Cleans leaves and grass clippings behind mowers.
- Rakes and performs general maintenance on bunkers.
- Assists with golf course set up procedures to include, but not limited to, changing hole locations and moving tee markers.
- Assists as directed on construction projects that involves sodding and seeding.
- Operates and performs preventive maintenance and minor repairs on golf course equipment, such as tractors, self-propelled mowers, irrigation equipment, trucks and a variety of hand tools.
- Performs other related duties as assigned.
