- Prepare appropriate documentation and records of drug usage.
- Answers questions, counsels, and advises customers on drug interactions, side effects, dosage, and storage of pharmaceuticals.
- Compounds medications, using standard formulas and processes.
- Serves as instructor for pharmacy student rotations.
