### Job Summary

Reporting to the Transit Service Supervisor, the University Shuttle Van Driver provides a safe and reliable transportation service to faculty and staff. Ensures operations are performed in accordance with University.

### Essential Functions

1. Safely operates state owned University vehicles while transporting passengers in accordance with all local, state, and federal traffic laws.
2. Provides customer service and information to passengers as necessary in a polite and friendly manner which may include resolving customer issues.
3. Ensures the University vehicle is clean and in safe condition reporting any problems or vehicle performance or maintenance issues immediately.
4. Report any accidents or injuries according to the written policy.
5. Assists with the training of new employees for driving techniques.
6. May perform other duties as assigned.

### Supervisory Responsibility

May be responsible for training, assisting or assigning tasks to others. May provide input to performance reviews of other employees.

#### Substitutions allowed for Education:

Indicated education is required; no substitutions allowed.

#### Minimum Required Knowledge

#### Certification or Licensure Requirements

Valid driver's license, clean driving record, and must pass the state driving exam to operate a state vehicle (DDC)

### Physical Requirements/ADA

Regularly involves lifting, bending or other physical exertion. Often exposed to one or more elements such as heat, cold, noise, dust, dirt, chemicals, etc., with one often to the point of being objectionable. Injuries may require professional treatment.
