JOB SUMMARY

Serves as the Research Security Threat Manager, Export Control Manager and Assistant Facility Security Officer for the Research Security Compliance Office. This position provides direction and guidance to senior level administrators, faculty, staff and students pertaining to all facets of the export control and research security programs.

RESPONSIBILITIES

- Assimilates, evaluates, and identifies information concerning counterintelligence and counterespionage threats against personnel, research programs, information systems and/or facilities. Provides senior level administrators, faculty, staff and students with direction, guidance and interpretation of federal government regulations and policies concerning classified, export control and controlled unclassified information.
- Conducts internal assessments of the university classified, export control and controlled unclassified information programs between scheduled government audits ensuring that controlled research information is being properly protected in accordance with government directives.
- Ensures that foreign national visiting scholars and international students who are invited to visit/attend the university are not on any U.S. government denied entity or program.
- Develops comprehensive security plans to ensure classified, export control and controlled unclassified information is afforded proper protection per applicable government standards.
- Serves as the Assistant Facility Security Officer.

The responsibilities listed above show the typical duties for jobs in this classification. Actual tasks may differ depending on the department's needs. Other similar duties may be assigned with discretion of the supervisor. Not every duty will apply to every position, and the amount of time spent on each task can change based on department needs.
