JOB SUMMARY

Oversees routine animal care and maintenance of equipment and facilities to meet regulatory requirements of the animal care unit.

RESPONSIBILITIES

- Supervises maintenance, repair, installation, and removal of equipment and facilities within the animal care unit.
- Manages procurement and logistical processes for equipment and supplies used in the animal care unit.
- Assists the director in planning, developing, and drafting protocols pertaining to employees, facilities and equipment.
- Assists in employee accident prevention, first aid programs, and safety operations in the animal care unit.
- Prepares and maintains documentation associated with animal care, animal census and facility repairs and maintenance.
- Supervises and provides daily management of animal care trainees, technicians, and technologists assigned to the animal care unit.
- Approves, prepares for and receives routine animal housing requests.
- Inspects buildings, fences, supplies and equipment in order to determine work to be performed.
- Performs quality assurance procedures to meet regulatory requirements of the animal care unit.

The responsibilities listed above show the typical duties for jobs in this classification. Actual tasks may differ depending on the department's needs. Other similar duties may be assigned with discretion of the supervisor. Not every duty will apply to every position, and the amount of time spent on each task can change based on department needs.

SUPERVISORY RESPONSIBILITIES
