## **Job Summary**

Responsible for providing daily care, cleanliness, and upkeep for a variety of laboratory animals located in a laboratory setting.

#### **Essential Functions**

- 1. Ensures animal cages and/or containment rooms are kept clean and orderly.
- 2. Launders, stores and distributes linens and scrubs required for animal care.
- 3. Restocks supplies needed for cleaning rooms and supplies needed for meeting animal needs.
- 4. May perform a variety of animal care duties such as (but not limited to) feeding, watering, applying shredded paper to cages and updating health records.
- 5. May perform a variety of animal care facility services such as (but not limited to) building "whelping boxes" and maintaining the upkeep of kennel grass and yard work.
- 6. Assists with animal treatment as needed.

## **Supervisory Responsibility**

May be responsible for training, assisting or assigning tasks to others. May provide input to performance reviews of other employees.

The above essential functions are representative of major duties of positions in this job classification. Specific duties and responsibilities may vary based upon departmental needs. Other duties may be assigned similar to the above consistent with the knowledge, skills and abilities required for the job. Not all of the duties may be assigned to a position.

## **Minimum Required Education and Experience**

**Level I** High school diploma or equivalent.

**Level II** High school diploma or equivalent plus 2 years of relevant experience. Experience must

include at least 2 years at the preceding level or equivalent.

**Level III** High school diploma or equivalent plus 3 years of relevant experience. Experience must

include at least 1 year at the preceding level or equivalent.

#### Focus of Education Focus of Experience

High School Diploma or equivalent Experience in animal care practices

#### Substitutions allowed for Education:

Indicated education is required; no substitutions allowed.

#### Substitutions allowed for Experience:

When a candidate has the required education, but lacks the required experience, they may normally apply additional appropriate education toward the experience requirement, at a rate of one (1) year relevant education per year of required experience.

#### Minimum Required Knowledge

#### **Certification or Licensure Requirements:**

Entry into level I requires passing the level I examination leading to certification as a Laboratory Animal Technician (AALAS). In order to promote to level II employees must pass level II of the AALAS examination. Full AALAS certification is required to promote to level III. When moving from the Animal Care Attendant job, because of passing the AALAS test, a reduction in salary grade will not be permitted. Therefore, you must pass level I and II before moving to level II in the Animal Care Tech job.

### Physical Requirements/ADA

Regularly involves lifting, bending or other physical exertion. Often exposed to one or more elements such as heat, cold, noise, dust, dirt, chemicals, etc., with one often to the point of being objectionable. Injuries may require professional treatment.

Routine deadlines; usually sufficient lead time; variance in work volume seasonal and predictable; priorities can be anticipated; some interruptions are present; involves occasional exposure to demands and pressures from persons other than immediate supervisor.

Job frequently requires standing, walking, reaching, hearing, handling objects with hands, and lifting up to 50 pounds.

Job occasionally requires climbing or balancing, stooping/kneeling/crouching/crawling, talking, .
