JOB SUMMARY

Manages and oversees matters of information technology (IT) security, university policy, information technology controls, audit projects, and serves as a resource to Auburn University management.

RESPONSIBILITIES

- Manages audit projects and conducts complex audit programs and projects to assist university management in identifying and mitigating risk.
- Reviews documentation of IT audit work and written reports to ensure that appropriate and sufficient information, data, or evidence has been gathered to achieve the project objectives.
- Serves as the primary liaison to the CIO's and ISO's for all four Auburn University divisions and provides information and recommendations to management as members of various university committees.
- Provides day-to-day guidance and direction to staff on appropriate steps to take to complete projects by reviewing and discussing the work plans for individual audits, investigations, or reviews.
- Provides training to staff in IT audit/investigative techniques and procedures and university operations, policies, and procedures.

SUPERVISORY RESPONSIBILITIES

Full supervisory responsibility for other employees is a major responsibility and includes training, evaluating, and making or recommending pay, promotion or other employment decisions.
