Job Summary

Performs duties related to the installation, removal, and maintenance of signs on university property.

Essential Functions

1. Installs and removes street signs on University streets and roads.
2. Installs and maintains street and parking lot markings.
3. Cleans and maintains University property and equipment.
4. Maintains inventory and orders materials.
5. Maintains records related to work performed and materials ordered.
6. Coordinates assignment and recordkeeping of room numbers.
7. May design signs for University property using computer programs.

Supervisory Responsibility

May be responsible for training, assisting or assigning tasks to others. May provide input to performance reviews of other employees.

The above essential functions are representative of major duties of positions in this job classification. Specific duties and responsibilities may vary based upon departmental needs. Other duties may be assigned similar to the above consistent with the knowledge, skills and abilities required for the job. Not all of the duties may be assigned to a position.

Job occasionally requires walking, sitting, reaching, climbing or balancing, stooping/kneeling/crouching/crawling, and lifting up to 100 pounds.
