## RESPONSIBILITIES

- Manages and coordinates the work and responsibilities of personnel by reviewing electrical tasks, inspecting job sites, revising instructions, and talking with other supervisors to ensure that all work is completed in a safe and efficient manner.
- Evaluates proposed electrical jobs in order to estimate and provide written and oral quotations.
- Plans and organizes electrical renovations and construction project requirements for facilities and infrastructure on university property.
- Communicate and coordinate regularly with others to keep them aware of activities of department and answer questions.
- Diagnose electrical problems and repairs and replaces equipment, units, and parts.
- Provides training on a regular basis with small group classes or independently to increase skill and knowledge of personnel.
- Approves invoices and oversees computer database for work activities, supplies, and equipment for accountability.
