### JOB SUMMARY

Maintains the athletic fields and landscaping around athletic facilities to include managing the turfgrass maintenance on Pat Dye Field to ensure optimal playing conditions. Responsibilities include scheduling maintenance, supervising staff, ensuring NCAA and SEC compliance, overseeing pesticide and fertilizer applications, coordinating daily operations, managing equipment and supplies, preparing the field for events, maintaining records, analyzing weather for scheduling, training and evaluating staff, and maintaining the athletic fields and landscaping around athletic facilities.

### RESPONSIBILITIES

- Oversees and coordinates daily operations related to turfgrass maintenance, ensuring the highest standards of care and maintenance.
- Formulates, schedules, and performs all necessary turfgrass maintenance practices on Pat Dye Field to ensure optimal playing conditions.
- Supervises and manages all turfgrass maintenance staff, both full-time and part-time, ensuring that tasks are completed efficiently and effectively.
- Ensures compliance with all applicable NCAA and SEC rules and regulations in the performance of job duties. Trains and supervises staff to adhere to these rules and regulations.
- Supervises and assists with the application of pesticides and fertilizers on all athletic fields and landscapes, ensuring compliance with safety and environmental standards.
- Ensures all maintenance equipment is properly used, maintained, and stored, and oversees the procurement of necessary supplies and materials.
- Prepares and maintains the field for all events, ensuring it meets the required standards for performance and safety.
- Maintains accurate records of all maintenance activities, applications, and staff schedules to ensure accountability and track progress. Trains, evaluates, and makes or recommends pay, promotion, or other employment decisions for all staff members.
- Complies with all applicable National Collegiate Athletic Association (NCAA) and Southeastern Conference (SEC) regulations in the performance of job duties.

The responsibilities listed above show the typical duties for jobs in this classification. Actual tasks may differ depending on the department's needs. Other similar duties may be assigned with discretion of the supervisor. Not every duty will apply to every position, and the amount of time spent on each task can change based on department needs.
