JOB SUMMARY

Provides supervision and services for the construction of building projects around campus.

RESPONSIBILITIES

- Plans and organizes project requirements for the construction, repair, and maintenance of buildings, grounds, and streets on Auburn University property.
- Manages activities and operations of construction personnel and subcontractors to ensure that all work is completed in a safe and efficient manner.
- Maintains records and documentation of work activities, supplies, and equipment for accountability.
- Communicates with others to keep them informed of activities within the department and to answer questions.

The responsibilities listed above show the typical duties for jobs in this classification. Actual tasks may differ depending on the department's needs. Other similar duties may be assigned with discretion of the supervisor. Not every duty will apply to every position, and the amount of time spent on each task can change based on department needs.
