Job Summary

Coordinates and oversees the business administration, performance tracking, and special projects of the Campus Services department of Auburn University Facilities Division.

Essential Functions

- 1. Coordinates the quality control and customer service assessment process which includes, developing surveys, collecting information, analyzing and summarizing data, and recommending improvement plans.
- 2. Provides service metrics for management reports; collects, analyzes, summarizes, and presents metrics to multiple levels of Facilities administrators.
- 3. Coordinates and oversees the preparation of statistical information used to make business decisions for the functional areas within Campus Services.
- 4. Develops and manages Service Level Agreements between Campus Services and business units on campus.
- 5. Oversees and tracks Building Services budgets, ensuring all financial transactions and records are accurate
- 6. Tracks and processes all purchase orders, bid proposals, and contract transactions.
- 7. Facilitates communications between clients, vendors, and all Campus Services functional areas.

Supervisory Responsibility

May be responsible for training, assisting or assigning tasks to others. May provide input to performance reviews of other employees.
